## • What's in Marc's Bag?

- In this session, we explored the crucial role of IT policies and procedures in a modern auditing practice.

  - During this session, we looked at overall strategies and metrics for resource management. Members also broke out into small groups to discuss how they handle resource management in their firms.

- Some initiatives our members discussed include SafeSend, SurePrep, offshoring, a new scheduling planner, and more.
