Trends for 2025

- During this session, we looked at the trends shaping the accounting profession so firm leaders can plan for the year ahead.

• Gaining Adoption and Evaluating Use Cases for Generative Al

- o This session explored how firms are leveraging generative AI to enhance workflows, collaboration and efficiency.
- Attendees gained insights into practical applications and learned strategies to drive engagement and adoption across the firm.

• Transformation Triangle Fundamentals

- In this session, we explored three essential frameworks: Process Improvement, Project Management and Change Management. We discussed how they work together to drive organizational success.
- Members learned how to optimize processes, manage projects effectively and navigate change to achieve business goals.

• How Firms Standardize Processes Across Multiple Offices

- During our "Ask Your Peers" session, a member asked how other firms with multiple offices standardize processes across locations while maintaining team engagement and visibility into local needs.
- Members discussed how they tackle the problem by appointing a managing partner for virtual offices and events specially designed for distributed teams.
